When he got back home, he emailed, saying the deal was postponed until the end of June or September, or maybe the end

of 2020 and could even be cancelled due to the virus.

I must admit, I was very frustrated, patience is not one of my giftings. Where was God in all this?

Does he not know that I am an amazing and incredible Christian and follower of Jesus! Why was he letting this happen to such a nice person as me?

Well the long and the short of it all, is that I persuaded the American's to use a local NZ accounting company to push the deal through on 30th June 2020.

While waiting the 3 months before this close off date, we hit 3 months of the highest sales in 37 years (during level 4).

We are an essential supplier of food packaging. Our sales were up about one third each month. (And the accrued profits Y.T.D, go to me, up to the company sale date.)

I had to apologise to God for my attitude and admit that I still had a few things to learn, and yes he is in control.

"Let not your heart be troubled......" It's easily said, but takes some trust and faith to appropriate.

## **David Fraser Testimony – Part 2**

Sometimes I had thoughts that seemed to me to be distractions or my mind straying but I later realised that these were thoughts God had put into my head.

As an example, I used to be the manager of all of the infrastructure at Hastings District Council: roads, water supply, storm water, wastewater, parks, buildings, and regional landfill. We had to apply for a consent for our wastewater discharge. At the time Hastings had the longest discharge into the ocean, two and a half kilometres long. It was the most monitored outfall in the country and it had been monitored for 30 years. Technically there was no "adverse" environmental impact, and everything was fine, so we applied for renewal of the consent.

The consent application went to a hearing. Maori appealed against it on the grounds that what we were doing was offensive to them on cultural grounds. This was because we were discharging raw human waste into the ocean. The commissioners at the hearing agreed with them and told us we had to try and sort something out. As a result, the whole process was put on hold.

We met with the leaders of the Maori community in Hawkes Bay and then went on a trip around the country with them looking at treatment plants. Through the process we got to know them pretty well. We visited a treatment plant near Papamoa. The Maoris called this the racetrack - it is technically known as an Oxidation Ditch. It has an elliptical channel. Fresh sewage is introduced at one point and then pushed around the channel where it is treated by naturally occurring bacteria within the waste stream. A portion is extracted as treated effluent at another part of the loop and would normally then go onto another treatment process. One of the Maori representatives who had worked at various treatment plants said something which astounded the Council's technical experts. He declared: "I would be happy if that stuff there went straight out to sea." We all looked at him and thought "This is mad!" "No" he responded, "it would be fine because from my perspective it is no longer human waste. By going through this process it has been transformed into bugs' waste, it has no human element in it any more, it's just like something that has gone in the long drop and had 6 months to decay and decompose. I don't find that offensive."

So, we then went through a process of looking at developing a plant. The Maori said, "We don't want something that is really expensive, because if it was too expensive our people will not be able to afford to live in the suburbs. They will come back to the marae which can't cope with so many people living there. We are sensible, but can you deal with the waste in a way that is no longer offensive?"

We looked for an affordable staged process. For sewage treatment you normally have a screening process, then a primary process, followed by a secondary process. At that point the sewage is pretty well treated. The Oxidation Ditch is a secondary process. Depending on where it is to be discharged you might require treatment to provide some final cleaning.

After talking it through we came to an agreement that we would build a primary process immediately and in 10 years' time a secondary process similar to the oxidation ditch in Papamoa. Council passed a resolution to approve our agreement, so I thought we had solved it.

My staff member, Bob, who ran our wastewater treatment plant was a scientist and was always experimenting and thinking creatively. He came to me and said, "I don't know why we are doing this." He had been involved in the process all the way through and he suggested we should build a biological trickling filter plant, preceded by our existing milliscreen and without the primary treatment. His reason was that it uses the same bugs and produces the same result as the oxidation ditch but is much cheaper to run. I thought "I'm not going to open this up again - it's taken us three years to get here, and I don't want to go back there" so I dismissed it. Shortly afterwards I was having a quiet time with God and felt prompted to talk to Bob and get some more information. So I did. He said: "Yes, we could do that but it's never been done at this scale before but there have been trials and theoretically it should work". I talked to my lead consultant, a very experienced engineer. He said: "I've got an English PhD engineer in Dunedin, a real smart process guy, he will know if this will work or not." So he talked to the process engineer in Dunedin who said: "Yes, it will work." He had seen a study 10 years previously where they had modelled a similar process and had built a small plant somewhere in England. He suggested we could probably look at it to see if it works.

I advised the Council that we had come across something that might be cheaper, and would like to send Bob and the English engineer, Pete, across to England to have a look the working plant. So off they went. to the plant in England had worked really well for its first 6 months until an ice cream factory was built right next door to it. When the factory began producing the most popular ice cream in the UK, production quadrupled and the plant was overloaded, became full of flies and a shambles. But the company who had built the plant suggested there were some plants in Spain to consider. So, I said "Seeing you have already gone that far, you better go to Spain." The plant managers in Spain were really interested in the concept and gave the go ahead to reconfigure one of their plants and gave permission to monitor it electronically. We wanted to install some Austrian monitoring equipment. We phoned the Austrian supplier to ask them to install their equipment in the plant in Spain so that we could data log the technical information back to our expert in Dunedin.

This was leading edge stuff because the internet

was not long available. The guys in Austria said the best person to install their equipment in the plant in Spain lived actually in Christchurch. We ended up sending a guy from Christchurch to install Austrian equipment in a plant in Spain to download information for an English PhD engineer

in Dunedin. Over 9 months he monitored the info. Over that

period Bob built a small scale biological trickling filter in Hastings so that the Maori could see how it worked and the end product.

The concept was interesting in that it did away with the primary treatment process, replacing it with what is called a milliscreen, a very fine metal screen which screens out the coarser solids (mainly grit and bits of plastic etc). The wastewater passes through the screen and then is pumped to the top of a biological trickling filter plant. It then trickles down through the filter. In the process the naturally occurring bacteria in the waste stream grows and eats the nutrients in the wastewater as it passes through, converting to nontoxic by-products. A totally organic process and about \$2.5 million per year cheaper to run than the "racetrack" version because it does away with the primary treatment and you don't have the high energy costs of constantly pumping the wastewater around the ditch.

After 9 months of monitoring Pete in Dunedin said: "Yes, you can go ahead." We then got a consent to build the new plant. In operating costs alone, we were going to save \$1 million per year on what the primary treatment would have cost. Added to that, we were not going to have to spent \$40 million building a secondary treatment plant in ten years' time which was then going to cost \$2.5 million per vear to operate. Over the 75-year life of that particular plant, the Hastings community will have saved about \$275 million. But it doesn't stop there. Napier were embarking on something similar, so they put their consent on hold while we built our plant. Over that 10-year period Napier saved \$35 million by not having to build and operate the plant they had planned and now they have a new plant up and running. So over the life of that plant they

> will have saved about million. \$350 Also, Gisborne came to see what we were doing, and they will save about \$300 million over the life of their plant. totalling to nearly a billion dollars over the life of those three plants.

> Spain had a string of plants along a river

system. They modified their plants to do away with primary treatment and go straight to secondary treatment:

the same as the one they trialled for us. This will have also saved them a fortune.

When looking back at this, it was nothing to do with me, I wasn't the guy who had the smarts behind making this system work. My only involvement was, when I was praying one morning, God prompted me to do something. I did what he prompted me to do and God then used a string of situations to bless three communities in NZ. It made me realise how much God is interested in us, how much he is interested in our daily lives, and how much he is interested in our communities. He tells us we are the salt of the earth and that we

have a role as salt to preserve, to encourage. I think it is really important for people in business not to see our work as being over there while our Christian life is over there. God really wants to mould our lives into one set of relationships He will use things we have never dreamed of or thought of to bless the community around us. Sometimes, like climbing Mt Maunganui, when we reach the destination we will look back and see God's touch on our lives. But when you are going up you simply have to hang onto the tree and pull yourself up because you are not sure exactly where you are heading and what the final outcome will be.
